8080 Campaign

Since 1996, KACE has assisted over 45,000 voters to register to vote. KACE spearheaded efforts to publish Korean language voter registration forms and participated in exit polls and poll site monitoring. KACE provides year round election information through annually publishes Primary and General Election guides, in Korean and English, and operates a voter assistance hotline during every election. Our goal is to increase Korean American voter registration rates and voter turnout rates to 80%.

Civic Education

In addition to assisting voters year round, KACE hosts an annual Grassroots Internship program to help the youth define their own Korean American identity and develop important civic leadership skills.

Registration **Eligibility**

To register to vote in New Jersey, all of the following conditions must be met:



- a. Be a United States citizen:
- b. At least 17 years old, but cannot vote until reaching 18 years of age.
- c. Resident of the state and county, city, or village for at least 30 days before the election;
- d. Not currently serving a sentence, probation or parole because of a felony conviction;
- e. Not be adjudged mentally incompetent by a court;
- f. Not claim the right to vote elsewhere

How to Register to Vote in New Jersey



- To register to vote, you must mail or deliver your Voter Registration Application to your County Commissioner of Registration or Superintendent of Elections for your county.
- Voter registration forms can be found on our website (www.KACE.org/election), at post offices, town halls, or other government offices. Once filled out, you can submit your form to KACE, to your County Commissioner of Registration, or Superintendent of Elections for your county in person or by mail.
- You can register to vote **online** if you have a date of birth and one of the following forms of identification:
- Current and valid Driver's License or a non-driver Identification Card (ID card) issued by the New Jersey Motor Vehicle Commission (MVC)
- Or a social security number
- If you would like to register to vote online, please visit https://voter.svrs.nj.gov/register and follow all instructions.

Primary Election Timeline / Jun 4

Deadline for Change of Party Affiliation (April 10)

- Declaration Forms for Primary Election to be Filed with County **Commissioners of Registration** (55 days before election)

Voter Registration Deadline (May 14)

- (21 days before election) Please Visit kace.org/election You may choose 'Online Voter Registration' or 'Voter Registration Form'.

Deadline to apply for a Mail-In Ballot by Mail (May 28) (not less than 7 days prior to election)

Early Voting Period (May 29~June 2)

- If you want to know the Early Voting poll site and voting hours, Please Visit kace.org/election then scroll down to Poll Site Locator then click 'NJ'.

Deadline for Application to Receive (May 31)

- Mail-In Ballots by Electronic Means for Qualified Overseas **Civilian and Military Voters** (4th day before election)

Deadline for In-Person (June 3 – by 3:00 p.m.)

- Mail-In Ballot Applications (up to 3:00 p.m. on the day before election)

Primary Election Day (June 4)

(Tuesday after first Monday in June)

- Deadline for post office receipt Mail-In Ballots.



General Election Timeline / November 4

Voter Registration Deadline (October 15) (21 days before election)

Early Voting Period (October 26 - November 3)

Deadline to apply for a Mail-In Ballot by Mail (October 29) (not less than 7 days prior to election)

Deadline for In-Person Mail-In Ballot Applications (November 4 - by 3:00 p.m.) (up to 3:00 p.m. on the day before election)

General Election (November 5)

(Tuesday after first Monday in November) Polls are open from 6 AM to 8 PM for All NJ Elections.

Early Voting Period

In 2024, New Jersey passed legislation introducing early in-person voting for both Primary and General Elections. This allows registered voters to cast their ballot in-person using a voting machine. Before you head to cast your early vote ballot, please visit https://voter.syrs.ni.gov/polling-place-search to see where your early voting poll site is and what hours the poll site will be open.

- Early Voting Period for June 4, 2024 Primary Election: May 29, 2024 to June 2, 2024.
- Early Voting Period for **November 4, 2024 General Election**: October 26, 2024 to November 3, 2024.

Poll Site and Time

You are only allowed to vote at your designated polling place. Before you head out to vote, you should check your polling place by visiting www.kace.org/election or by visiting https://voter.svrs.nj.gov/polling-place-search.
