Since 1996, KACE has assisted over 45,000 voters to register to vote. In the past, KACE has spearheaded efforts to publish Korean language voter registration forms and has participated in exit polls and poll site monitoring. KACE provides year round election information through annually published Primary and General Election guides, in Korean and English, and also operates a voter assistance hotline during every election. Our goal is to increasing Korean American voter registration rates and voter turnout rates to 80%.

Civic Education

In addition to assisting voters year round, KACE hosts an annual Grassroots Internship program to help the youth define their own Korean American identity and develop important civic leadership skills.

Registration **Eligibility**

To register to vote in New York, all of the following conditions must be met:



- a. Be a United States citizen:
- b. Be 18 years old by next election day; (You may pre-register to vote at 16 or 17, but cannot vote until you are 18)
- c. Resident of the state and county, city, or village for at least 30 days before the election;
- d. Not currently serving a sentence, probation or parole because of a felony conviction;
- e. Not be adjudged mentally incompetent by a court;
- f. Not claim the right to vote elsewhere

New York Voter Registration Guide



- You can register in person at your county board of elections or at any New York State Agency-Based voter registration center.
- You may register to vote by using the New York State Voter Registration Form which can be found on www. kace.org/ **election**, at post offices, town halls, or other government offices. Once the form is completed, you need to print the form and sign it. New York State Board of Elections cannot accept any kind of digital or Adobe-generated signature. Once the form is completed you can submit your form to KACE or mail/deliver the form to your county Board of Elections.
- You can request a New York State Voter Registration form by mail by entering your information at: https://www.elections.ny.gov/VoterRegSite/VoterRegistration
- You can call New York's hotline 1-800-FOR-VOTE to request a voter application.
- If you have DMV-issued identification, you can register to **vote online.** You can submit your voter application form online on the Department of Motor Vehicles' website. To register online, you need the following:
 - NYS Driver License, permit, or non-driver NYS ID card:
 - ZIP code currently on record with the DMV;
 - Last 4 digits of your Social Security Number (SSN).

Presidential Primary Election Timeline - April 2. 2024

03/23/24 - Last day voter registration application must be received by BOEs by mail or in person.

03/23/24 - Last day application for absentee ballot must be received by Board of Election.

03/23/24 - 03/30/24

- Days of Early Voting for the Presidential Primary Election.

04/01/24 - Last day to apply in person for absentee ballot.

04/02/24 - Last day to postmark ballot and the postmarked absentee ballot envelope must be received by the BOEs by April 9, 2024.

04/02/24 - Last day to deliver absentee ballot in person to **County Board of Election.**

General Election Timeline : June 25

10/21/24 - Changes of address Deadline

10/26/24 - Last day for board of elections to RECEIVE absentee application by mail or online.

10/26/24 - Voter Registration Deadline

10/26/24 - 11/3/24

- Days of Early Voting for the General Election.

11/04/24 - Last day to apply in person for general election ballot.

11/05/24 - Last day to postmark general election absentee ballot. Must be received by the county board no later than Nov 12.

Last day to deliver general election ballot in person to your county board or poll site in your county, by close of polls on election day. Polls are open from 6 AM to 9 PM for Election Dav. (Early Voting hours may very)

Primary Election Timeline : June 25

02/14/24 - A change of Party enrollment received by the **BOE** not later than Feb. 14

06/10/24 - Changes of address Deadline for Primary received by this date must be processed.

To change it, visit **kace.org/election** then you may choose 'online voter registration' or 'Voter Registration Form'.

06/15/24 - Voter Registration Deadline for Primary:

Last day application must be received by board of elections to be eligible to vote. To Register to Vote, Visit **kace.org/election**

06/15/24 - Absentee Ballot Apply Deadline Last day to **RECEIVE** absentee application by mail or online portal for primary ballot.

To apply it, visit **kace.org/election**, find 'Find Online Absentee Ballot Application' and click 'NYC' or 'NYC' or 'NY'

06/15/24 – 06/23/24

- Days of Early Voting for the Primary Election.

To check polling locations and times, visit kace.org/election, find 'Find a polling place' and click 'NYC' or 'NY'.

06/24/24 - Last day to apply in person for primary ballot.

06/25/24 - Last day to postmark absentee ballot.

Must be received by the county board no later than July 2.

Poll Site and Time

You are only allowed to vote at your designated polling place. Before you head out to vote, you should check your polling place by visiting www.kace.org/election or by visiting https://voterlookup.elections.nv.gov/.

Primary Election Day:

- Polls are open from 6 AM to 9 PM.

General Election Day:

- Polls are open from 6 AM to 9 PM.

(Early Voting hours may very)
